OFFICE ORDER No. 101 /2024(Civil)

Sh. Y.K. Goyal, enlisted in the Delhi Development Authority (DDA) as Class-III(B&R) vide office order No. 81/2021 dated 07.07.2021, had its enlistment valid until 06.07.2026. However, based on a recommendation by the Chief Engineer (East Zone) DDA, through the e-office, the case of **Sh. Y. K. Goyal** was reviewed for suspension/debarment from tendering in DDA, as per terms and conditions of the Rules for Enlistment of Contractors in DDA, 2022 mentioned below:

Clause 13.6 Debarment of contractor

The contractor may be debarred if any of the following is established by enquiry:

- (a) Fails to execute a contract or executes or executed it unsatisfactorily; or
- (s) Supply of sub-standard material, non supply of material, abandonment of works, sub-standard quality of works


As per Chief Engineer, East Zone, after taking over the possession of site the agency has deliberately dumped a huge amount of malba at site with intension to use it instead of screened soil for filling purpose. The agency also neglected the directions from Engineer-in-charge to remove the malba and provide structural drawings that are compatible with the architectural drawing. The agency has removed the malba from site after a huge lapse in time and does not carry out the work as per direction of engineer-in-charge leading to determination of work by EE/EMD-2 after issuing several show cause notice to the agency.

Accordingly, office memorandum has also been issued to the agency by Secretary(CRB) and the agency has given reply vide letter dated 27.05.2024.


The case with reply to the office memorandum provided by the agency along with the comments of CE(East Zone) on the reply were presented before the board on 25.06.2024. After careful deliberation and discussion, the board concluded that the agency's reply was not convincing and case also considered the recommendation of Chief Engineer (East Zone) for debarment. As a result, the board recommended the debarment of Sh. Y.K. Goyal from tendering in DDA for a period of one year. Based on the board's recommendation, the competent authority approved the debarment of the contractor for one year.

Therefore, Sh. Y.K. Goyal is hereby debarred / suspended for a period of one year from the date of issue of this order for further tendering in DDA.
